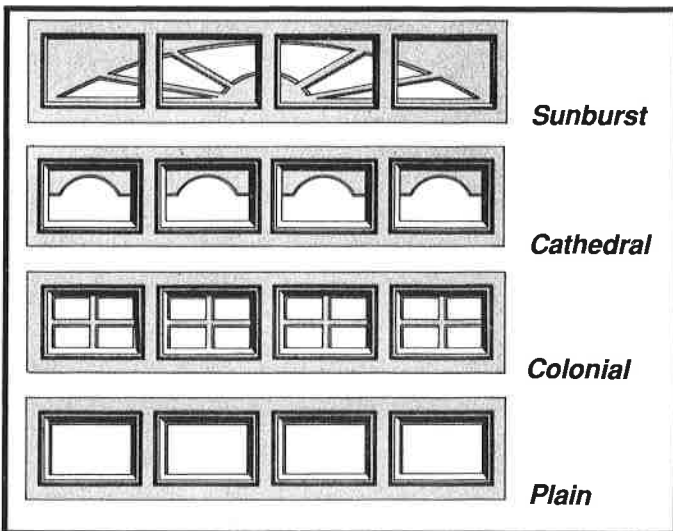

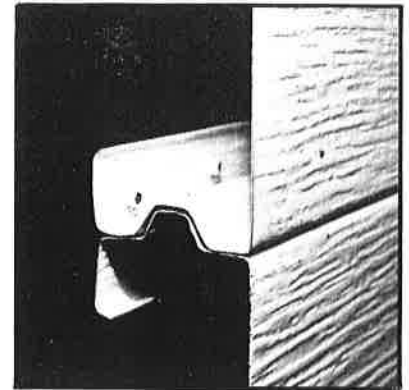

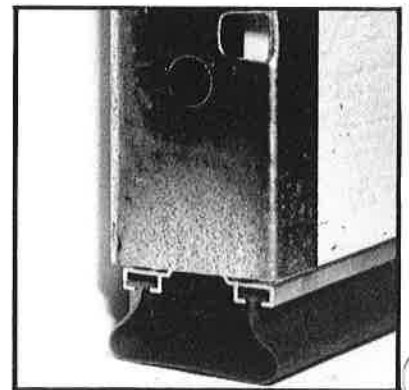

If, within the terms of the warranty, the door sections are found to be defective upon inspection by authorized Arm-R-Lite personnel, Arm-R-Lite will replace the defective door sections. Labor charges shall be the responsibility of the consumer. This warranty covers only the sections and does not apply to any damage or deterioration caused by abuse, paint failure or failure to provide reasonable and necessary maintenance. Arm-R-Lite shall not be liable for any consequential or incidental damages. Further, the rights granted under this warranty shall be voided when repaired by any party not authorized by Arm-R-Lite.

Arm-R-Lite warrants each garage door part, excluding garage door sections to be free from defects in material and workmanship for one (1) year from the date of purchase, to the original purchaser. If, within the term of the warranty, a part is found to be defective upon inspection by authorized Arm-R-Lite personnel, Arm-R-Lite will replace the defective part. Labor charges for installation and freight charges shall be the responsibility of the consumer. This warranty does not apply to any damage or deterioration caused by abuse or failure to provide reasonable and necessary maintenance. Arm-R-Lite shall not be liable for any consequential or incidental damages. Further, the rights granted under this warranty shall be voided when repaired by any party not authorized by Arm-R-Lite.
